SUPERINTENDENT REPORT:

Mr. Stephenson states that there was a smooth start to school. Administration and staff did a great job.

Mr. Stephenson states that staff is completing the Safe Schools Training with the software acquired last year.

Mr. Stephenson states that we received a copy of the revised NEOLA book. Mr. Stephenson's goal by the next Governing Board meeting is to have gone through each page and verify that the recommended changes have been made.

Mr. Stephenson states that after NEOLA has been verified we may want to consider a workshop to go over revisions.

Mr. Stephenson thanked those involved for their help in preparing for the Strategic Planning Session that is to follow the regular Governing Board meeting this morning. He also thanked Steve Pohlman for allowing us to use the Yacht Club facility.

CHAIRMAN REPORT:

Chair Jackson states that her report is a personal one.

Chair Jackson states that she attended the "Boo-Hoo Breakfast" at OES.

FOUNDATION REPORT:

Chris Porter states that the Foundation held their regular monthly meeting last week. They are working as quickly as possible to get some green on the field behind OHS.

Chris Porter states that they are beginning to plan the Rally; they cannot finalize the date until September 22, 2015. The Foundation would like to have the rally earlier in the year so it is not quite as hot.

STAFF AND BOARD COMMENT:

Business Manager

Mary Anne Moniz thanks Mr. Rivera for donating the parking stops for the OHS student parking area.

Mary Anne Moniz thanks Steve Pohlman and the staff from Parks & Rec. for allowing us to use their facility.

Mary Anne Moniz states that she would like the board members to review the adopted budget book given to them. She also states that if the board has any suggestions to please let her know. It is her goal to make it a valuable tool for them.

Mary Anne Moniz states that since the budget has been adopted the PECO budget was released and it was approximately \$500,000.00 less than anticipated. The main reason it came in so much less was because at the time of our proposed budget it hadn't gone out to be bonded. She also stated that there was an additional 45 qualifying Charter Schools this year.

Mary Anne Moniz states the Legislature has released their 2016-2017 proposed budget and it looks like PECO dollars will continue to decline.

Mary Anne Moniz states that final enrollment numbers are due tomorrow. These numbers will be used to determine our FEFP funding.

Mary Anne Moniz states that the school kick-off went very well but there were some equipment issues:

- 2 refrigeration units in food service were malfunctioning
- 1 A/C unit in one of the portables at CME needed to be replaced
- OMS gym curtain is not working properly
 - o Tried to replace the motor
 - o May have to go to a manual system instead of motorized
 - The cost is estimated between \$13,000.00 and \$15,000.00. Parks & Rec. department may be able to contribute funding towards repairs

Mary Anne Moniz states the final vote to receive \$100,000.00 from City Council happens this week. We need to identify what items we would like to use that funding for.

Discussion held.

Director of Procurement and Food Services

Danielle Jensen states that all of the required food service training has been completed as well as getting the kitchens cleaned and prepped for the start of school.

Danielle Jensen states that our National School Lunch Program (NSLP) application has been approved by the state. We have already processed over 1000 applicants within the first two weeks of school.

Danielle Jensen states that she has received questions as to why we do not have free lunch for all of our students. She explained that we do not have a large enough percentage of students on the free and reduced program to qualify. There is a minimum requirement for the program.

Danielle Jensen states that she has been busy with procurement needs.

Christa McAuliffe Charter Elementary School

Jacque Collins states that CME had a great beginning to the school year.

Jacque Collins states that car lines are down to normal time now.

Jacque Collins states they are doing "Curriculum Nights" in September.

Jacque Collins recognized Melissa Meehan for her work in kicking off the Watchdog Program. The kick-off will be Thursday, September 10, 2015 at 7:00 PM. They are expecting 500 in attendance.

Jacque Collins states there are field trips planned to St. Augustine and M.O.S.I. (Museum of Science and Industry).

Oasis Charter Elementary School (OES)

Steven Hook states they had their annual Boo-Hoo Breakfast this morning.

Steven Hook states that they have adapted to more people being in the car line. They went to double staff in the back and this allowed them to start on time every day.

Steven Hook states that the Fall Festival will be coming up in November.

Steven Hook states the Flats Tournament was a great event.

Oasis Charter Middle School (OMS)

Keith Graham states that OMS Open House was a great success.

Keith Graham states that OMS club organizations are off and running.

Keith Graham states that the S.T.E.M. students are soon beginning an aquaponics and gardening project that will cross the curriculum.

Keith Graham states they are in the final week of their Great American Fundraiser.

Keith Graham states the Washington D.C. informational meeting for parents will be September 15, 2015.

Keith Graham states the Science Fair informational meeting will be September 17, 2015.

Keith Graham states there is a volleyball game on September 9, 2015. Both JV and Varsity teams play.

Keith Graham states their first PTO meeting is this evening, September 8, 2015. Keith Graham states the Back to School Dance is September 25, 2015.

Oasis Charter High School (OHS)

Shannon Treece states that OHS is now fully staffed.

Shannon Treece states there was a clip on Wink News highlighting the Technology Day that was hosted at OHS. Mr. Prawitz is the individual teacher who agreed to take on technology that is integrated around NextGen Learning and created a model classroom.

Shannon Treece states that they are implementing Schoology. This is an integrated learning management system and will be an added layer of communication for parents, students and teachers.

Shannon Treece states they are working on student emails. This will enable a direct line of communication to students.

Shannon Treece states they are utilizing the K12 Alert System to communicate with parents. A newsletter will be sent out to parents every Friday .

Shannon Treece states that interaction with the students has been very positive. Students are very engaged in the work that's happening within the clubs.

Shannon Treece states that athletics have begun at OHS. Several sports' seasons have begun.

Shannon Treece states that college night is September 9, 2015.

Shannon Treece states that as a new person coming in to our system, she feels there is an open line of communication between the building principals.

Shannon Treece states that it has been busy but fun.

Member Boyer thanked Principal Treece for including them in the K12 Alerts.
